Quizzes

There will be 10 required quizzes to check your knowledge of content addressed in this course. All quizzes are open from the first day of class and will have due dates. Quizzes will close on that date and will no longer be available to take. All quizzes are due by 11:59 pm on the date assigned. \*Keep in mind that the practice questions, found under the "Test Yourself" section in the reading are very similar to the questions on the quizzes and make for good practice

# Group Project (Teamwork)

Teamwork is behaviors under the control of individual team members (effort they put into team tasks, their manner of interacting with others on team, and the quantity and quality of contributions they make to team discussions.)

There will be a separate "group project" module embedded into the course with all relevant information regarding rubrics, topics, group assignments, and assessment of the project.

Grading for this project will be based on the Team Work Value Rubric Two grades will be necessary in this assessment: my grading of your work 9up to 100 pts) and your combined grading of each other (up to 50 pts). In each case, the Rubric will be followed.

### Exams

There are two major exams for this course, a Midterm and a Final Exam. The midterm covers lessons 1-20, consists of 80 questions and you will have 2 hours to complete the exam on the course website. The final will be a concert review which will be discussed in detail in a different section.

### Discussions

There will be 4 discussions required in this course in an effort to create community and to have the opportunity to talk about music. We will have the following discussion topics:

- 1. Introduction we will introduce ourselves, identify our previous musical backgrounds (were you in band, choir, sing in the shower...)
- 2. What is the Performer's Role in Music?
- 3. Elvis
- 4. World Music What do you think? Does music from other countries influence what we hear today? Etc.

You will be required to have an original post (all about you) and respond to at least 3 other student posts. Point breakdown:

Original post = 10 points

3 responses to other's post = 30 points

Timeliness points (your Original post is made prior to the date listed in the discussion prompt) = 10 points

(If you wait until the last minute, other students will not have the ability to post to you and you will lose points!)

## Final Exam

Your final exam in this class will be a Concert review. This will be a 2-4-page written concert review. Specific information regarding this assignment will be available in the Final Exam module. Keep in mind that I would prefer a live concert; however, in some instances, a full online concert will be accepted. I will have all requirements available in the module so that you can plan ahead. Proof of attendance will be required.

### Change of Schedule
