Assignment 3: Leadership Paper (3-pages double spaced) (100 points) Due Jan 29th

Strong leadership is one key challenge successful teams must have. The book discusses five different aspects that can lead to the failure of a team. Discuss each component and explain how to implement each one successfully. Discuss the importance of each step.

- In a 3-page paper, discuss each component in detail.
- Discuss how to implement each component.
- Give examples where relevant.
- Use APA formatting, title page, reference page, and numerous citations.
- Research each component using peer-reviewed sources.
- There is significant research on all components in this class; ensure you use quality references.

Assignment 4- Management Style (100 points) Due February 5th Chapter 1 and 2

• Submit a 3-5 page paper double-spaced and APA formatted. 2 peer-reviewed references and in-text citations.

- The paper's first section should discuss the different management philosophies found in Chapter 1.
- The last page clearly articulates your management philosophy and why. Also, discuss why that management philosophy will be beneficial in the sports and leisure fields.
- Submit a Flip articulating your management philosophy within a 2-3-minute time frame.
- Comment on two classmates after you have completed your Flip. Think as though you were going to hire them and ask questions based on their presentation. Present to others only after you have published yours. The date is visible.
