COURSE REQUIREMENTS

Instructional Methods and Assignments

This is an online Competency Based Education (CBE) course. Learning activities include assorted readings, videos, and activities in addition to project-based assessment that require you to demonstrate competencies and learning. All assignments must be completed at the proficient or accomplished level to move forward in the course.

Learning Theories Presentation

You will be expected to provide an interesting, engaging, research-based presentation on learning theories relevant to early childhood education. Since most of you are planning on becoming educators, it is important to develop presentation and communication skills that teachers, and other professionals, will use on a daily basis.

The presentation will be a 15 to 20-minute (minimum requirement) recorded presentation with audio and video (including slides/graphics). See assignment instructions in the course for detailed information and requirements.

You must score at or above 80% to pass the assessment.

Developmental Stages Paper

You will research and analyze multiple theories of early childhood develop. Your paper will cover physical, cognitive, social, and emotional domains of child development and how changes in development may impact teaching and learning in an EC-3 educational setting. See assignment instructions in the course for detailed information and requirements.

You must score at or above 80% to pass the assessment.

Motivation and Engagement Brochure

As a classroom teacher, you will likely have parents come to you to ask for help in improving

student motivation and engagement in the classroom. In order to demonstrate your ability to apply the theories from the course into a real-world classroom context, you will create a brochure that you would distribute to parents to provide them with suggestions to increase their child's motivation and/or engagement in your classroom or at home. You must score 80% or higher to pass the assessment.

Texas Education Agency Training Modules

One of the requirements of the Texas Education Agency is that teacher candidates complete online trainings in substance abuse prevention, at- risk (youth suicide) prevention, and mental health awareness. In this course, you must complete all three. For teacher candidates, you must submit your completed training certificates to TK20 by the due date, where they will be in your permanent file. If you do not complete these trainings during this course, you will not pass and will be required to repeat the class.

Module Assessment (Assignment) Grading

The Module Assessments are assessments of your knowledge of the material required for the successful completion of this course. A score of 80 points or higher is required to demonstrate competency in the module topics.

If you score less than 80% on any module assessment (required course assignment), you will have an opportunity to review the material, revise, and resubmit the module assessment. All assessments must be completed with at least an 80% score before the end of the course or you will be required to retake the course.
