Course Description

This independent study will introduce cybersecurity practices of penetration testing. Virtual machine environments will enable exploiting system vulnerabilities freely but safely by deploying offensive security principles and determining how to avoid such problems. This course will utilize an effective active learning environment that will help learn by doing and master security techniques. Experiments using Kali Linux, an established offensive security platform, Ubuntu, a popular Linux distribution, as well as Wireshark, a widely used packet analyzer tool, will be used to provide essential hands-on experience.

- 5. Penetration-test a target system using Metasploit, an industry-standard tool.

Class Policies

Flipped Classroom

Readings from the textbook and/or other sources and videos will be announced prior to class sessions. You will complete reading and watching these videos before class. In each meeting we will briefly discuss the material and assignments based on this material.

Assignments

These fall in two categories.

Quizzes: We will work on quizzes that will validate the readings. The grade from the quizzes will constitute 20% of the total grade.

Assignments: You will use various tools and virtual machines to practice on the topics that you are learning, and to explore some ideas more deeply. The grade from the assignments will constitute 30% of the total grade.

Research Project

You will select a topic that will require you to study some aspect of the "real world" penetration testing topic in detail. A possible outcome of the project will be an oral or poster presentation at MSU UGRCA Forum in November.

<u>Exams</u>

There will be one exam.

For planned absences: Exam may be taken early by prior arrangement. For unplanned absences: Students need a valid university excuse (e.g., excuse from the doctor, death in the immediate family, etc.). The missed exam will be replaced with the final exam grade.

Computer Requirements

Taking this class requires you to have access to a computer (with Internet access) to access online course material. Personal computer technical difficulties will not be considered a reason for extra time to submit assignments, tests, or online discussion postings. Assignment Submission Policy

Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester is eligible for a100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester.
