Course Description:

The mission of this course is to refine musical, technical, and pedagogical skills as pertain to trumpet playing. The student will be expected to dedicate a minimum of 2 hours to focused daily practice. The student will be expected to avidly pursue the development of adequate fundamental skills to perform in any musical setting. Essential trumpet fundamentals include a demonstration of excellent sound production, intonation, flexibility, articulation, style, time, rhythm, sight-reading, and transposition. These skills will be applied to lyrical and technical etudes, as well as standard repertoire. Preparation of a selected piece of repertoire will be assessed at the end of the semester in the form of a jury. Your progress is more important to me than your individual performances. Quality is always valued over speed.

The student is expected to be warmed up and ready to play at the beginning of each

lesson. The student's instrument should be in working condition.

Daily practice is essential to being successful in this course. A missed day of practice is lost forever.

I am here to support you in the pursuit of your goals.

Evaluation:

Students will be assessed on their weekly preparation, lesson attendance, scale test scores, and jury performance.

Scale Tests: 10% each (2 scale exams per semester)

Weekly Preparation: 60%

Jury/Recital Performance: 20%
