Course Description

This course will introduce the major movements in French literature from the beginning of the 20th century to today. In our study of the period, we will read texts that exemplify literary or philosophical movements like Surrealism or Existentialism. We will also encounter works belonging to distinct literary genres, such as the novel, and still others that challenge these established literary forms. The course will be conducted entirely in French and all assignments will be completed in the target language. Students will improve their language skills through class discussions, oral presentations, film viewings, readings, written film reviews, and reaction papers.

Skills and Outcomes

In this course, students will (1) learn about major literary movements of French literature in the 20th and 21st centuries (2) analyze French literature through readings, guided class discussions, presentations, and analytic written assignments.

The comprehensive final exam covers all materials studied during the course. The exam consists of multiple choice, matching, and/or written/short answer portions.
