<u>**Textbook:**</u> No textbook is required for this course. All required reading materials will be provided via D2L by the instructor.

Course Objectives:

- 1. Gain an understanding of the anatomy and physiology of the heart.
- 2. Understand the effects of acute and chronic exercise on a variety of cardiovascular parameters.
- 3. Develop the skills necessary to administer and interpret an echocardiogram.
- 4. Identify abnormalities in heart rate, various waveforms, intervals, segments, and complexes associated with ECG.
- 5. Interpret the underlying mechanisms associated with ECG abnormalities.

Course Evaluation: Evaluation of the course material will be broken down between five (5) article review assignments throughout the semester, 3 (3) ECG analysis assignments, and three (3) exams. College Policies

Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester. HOWEVER, if the student received financial aid (federal/state/institutional grants, loans and/or scholarships), all or a portion of the refund may be returned to the financial aid programs. Smoking/Tobacco Policy

Alcohol and Drug Policy

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes has prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
