Course Description

This course provides a comprehensive overview of the organization, leadership, and management of early care and preschool programs. The course will cover personnel, fiscal, and facilities oversight and management; professional ethics; NAEYC's Code of Ethical Conduct for Early Childhood Program Administrators; state law and licensing regulations; program marketing; program evaluation, and staff training/professional development.

Identify and demonstrate understanding of ethical responsibilities to children, families, personnel, sponsoring agencies, governing bodies, community, society, and the field of early childhood education as identified int he NAEYC Ethical Code of Conduct (Ethical Code of Conduct for Program Administrators, NAEYC 1-3)

- 2. Explain, identify, and demonstrate understanding of policies, procedures, and systems that support stable staff and strong personnel, fiscal, and program management so all children, families, and staff have high-quality experiences (NAEYC 10).
- 3. Explain, identify and demonstrate understanding of Texas state law and licensing regulations related to preschool and early care settings including: staff-child ratios, training and facilities requirements and oversight, fiscal responsibilities, procedural documentation and record keeping, food handling and safety, professional development, and program evaluation.
- 4. Create an overall budget for a preschool and early care program.
- 5. Identify and create a program marketing plan for a preschool and early care program.

Submitted Work

Attendance

Students are expected to attend all meetings of the classes in which they are enrolled. Although in general students are graded on intellectual effort and performance rather than attendance, absences may lower the student's grade where class attendance and class participation are deemed essential by the faculty member. In those classes where attendance is considered as part of the grade, the instructor should so inform students of the specifics in writing at the beginning of the semester in a syllabus or separate attendance policy statement. An instructor who has an attendance policy must keep records on a daily basis. The instructor must give the student a verbal or written warning prior to being dropped from the class. Instructor's records will stand as evidence of absences. A student with excessive absences may be dropped from a course by the instructor. Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees. Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester. Smoking/Tobacco Policy

The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
