COURSE DESCRIPTION: This course prepares students to critique research literature for appropriateness and utilization in nursing practice. Emphasis is placed on increasing knowledge and skills related to the development and evaluation of research proposals. Both quantitative and qualitative methodologies are explored.

#### SUBMISSION OF ASSIGNMENTS:

Timely submission of all assignments is required. In the event a student needs an extension due to compelling circumstances, communicate with faculty in advance of the due date. #### Response Post:

To allow students time to make edits before submitting the final paper to Dropbox, peer Reviewers are expected to review the draft <u>within five (5) business days</u> of the initial post-due date program. Please review the grading rubric for the Literature Synthesis (to guide your feedback) AND the Writing Tips sheet <u>before</u> responding to your classmates.

Please save all of your work, in case D2L or the internet crash, so that you do not lose your work.

#### **MODULE QUIZZES:**

All Module Quizzes are opened at 8:00 AM at the beginning of the module and closed at 11:00 PM on the date indicated on the class calendar. Students may take a Module Quiz as many times as they wish during the open period. Following each attempt, students will be provided with a score, but students are not provided correct answers.
