Projects Required

- 1. Strategy Portfolio for your content area (30% of your total grade)**

- a. Before Reading (10)
- b. During Reading (10)
- c. After Reading (10)

2. Reading Plan (25% of your total grade)

- a. Select reading material in your area. This can be a book, newspaper article, archival data, a play, music, etc.
- b. Create a before – during – after plan specifically related to your material selection.
- c. Provide outlines and examples of all your activities
- d. Reflect on how this may enhance your teaching in the classroom and how it supports comprehension.

Discussions

Reflective discussions in this course are worth **35% of your grade**. You must participate in them ontime. All initial posts are due Wednesdays at 11:59PM and all peer posts (2 required for each discussion) are due Sundays at 11:59PM. The deadlines never change so please plan accordingly.

Attendance

Students are expected to attend all meetings of the classes in which they are enrolled. Although in general students are graded on intellectual effort and

performance rather than attendance, absences may lower the student's grade where class attendance and class participation are deemed essential by the faculty member. Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees.
