### **Course Description**

Techniques and procedures utilized in the supervision of adult and juvenile probationers and parolees, and other residents of community-based corrections facilities. Preparation of social history, pre-hearing, and presentence investigation reports. Emphasis on practical problems confronting the probation and parole and other community-based corrections officer.

### <u>Course Objectives</u>

2) Critically evaluate current qualitative and quantitative research pertaining to community corrections, *demonstrated by obtaining passing scores of a "C" or better on related essay-based assignments and objective-item examinations*.

3) Compare and contrast the functions of probation with those of parole, *demonstrated by obtaining passing scores of a "C" or better on related essay-based assignments and objective-item examinations.* 

4) Identify the various components of community corrections, *demonstrated by obtaining passing scores of a "C" or better on related essay-based assignments and objective-item examinations.* 

5) Identify and utilize specific treatment strategies with offenders on community supervision, *demonstrated by obtaining passing scores of a "C" or better on related essay-based assignments and objective-item examinations.* 

### **Course Requirements**

<u>Midterm Examination</u> – This examination will be given during the midpoint of the semester and will include information presented in the chapter readings. The Midterm Exam will primarily consist of multiple choice, true/false, and essay items may also be included. The exam will be conducted online. Each student must take and finish the test within the time allotted.

**Final Examination** – This examination will be given during the last week of the semester and will include information presented in the chapter readings. The Final Exam will primarily consist of multiple choice, true/false, and essay items may also be included. The exam will be conducted online. Each student must take and finish the test within the time allotted.

<u>Class Discussions online</u> – Every week throughout the semester discussions will be held in the online courseroom. These discussions will revolve around the assigned readings. <u>Research Paper</u> – An original research paper between 10-12 pages is required for this course. You must pick a topic from those available at the end of this syllabus and complete the paper on that topic. You must use strict APA format, include a title page, and abstract, and references, all separate from the 10 to 12 pages of the main body of the paper. Papers are to be double spaced and in 12 point Times New Roman font.

NOTE that your research paper is due by 5:00 p.m. on November 20<sup>th</sup>, 2022.
