#### **COURSE OBJECTIVES**

- ✓ learn about what psychology is, and how it is applicable to the world around us.
- ✓ understand how we learn, think and remember.
- ✓ gain a basic knowledge of human developmental processes
- ✓ learn about human characteristics such as intelligence and personality
- ✓ investigate problems in human functioning (psychopathology) and how such problems are treated.

Above and beyond this, we will approach the field of psychology critically as "a way of approaching and analyzing the world (Wade & Tavris, 1990, p. xvii)." This means that we will explore how to think critically about psychological phenomena and be skeptical about what we read.

As such, class discussions and projects will be designed to encourage your own exploration of psychology. Through the study of this field, you are likely to find that much of what we know in psychology directly relates to, and has the capacity to enrich, our experience of everyday life.

**EVALUATION AND ASSIGNMENT OF GRADES** 

<u>Examinations</u>: There are four major exams. Each of the first 3 exams will cover 3 chapters.

Each of these exams is worth 25% of your grade. They are multiple-choice and each will consist of 50 - 70 questions.

The final exam is comprehensive and will contain 50 multiple-choice questions and is worth 10% of your final grade.

Theme Papers: Fifteen percent of your grade (15%) will be determined based on your completion of three Theme Papers. These papers will be no less than 500 words each and will need to be submitted electronically via D2L. The total number of points you can earn from these papers is 150, or 50 points per paper. The papers will consist of your application of concepts discussed in class, covered in your text, current events, or personal experiences. For example, you might decide to do one of your Papers on the impact of the Internet on how students learn, or the impact of teenage violence on psychological health later in life, or the impact of memory deficits on academic achievement, or the use of principles of learning to help at-risk youth acquire positive social skills.

Theme 1 topics – Circadian Rhythms, Sleep problems, Drugs, Phobias, classical conditioning, observational learning.

Theme 2 topics – nature/nurture, teratogen effects, adolescence, young adulthood, death and dying, Sex, gender, social issues

Theme 3 topics – therapy, types of therapy, stress, disease risk, health psychology

<u>Research Requirement</u>-It is important that students of scientific psychology learn firsthand something about the scientific nature of the discipline. Therefore, all students in PSYC 1103 and 2203 are required to participate in one of the two following research-related exercises. **The deadline for completing the research requirement is 2 weeks before finals week.** 

1. Participate in one or more psychology research projects totaling at least 60 minutes. Research opportunities will be announced throughout the semester in postings that appear at

OR

2. Complete a research ethics essay. Participating students will read academic writings addressing research ethics. Following this, students will complete a 3-4 page double-spaced, typed summary and review of the information they read. Tables, figures, pictures do not count toward the minimum page requirement. Essays must be submitted no later than the second to last week of class.

No credit will be awarded for participation, but students must complete one of the two above options. Failure to do so will result in a letter grade reduction for the course.

<u>Grading</u>: Each regular exam will represent 25% of your final grade and the final 10%. Fifteen percent of your grade will come from your submission of the Theme Assignments.

# III. RELEVANT CLASS, PROGRAM AND SCHOOL POLICIES

Late submission of theme papers. Not allowed.

Academic Dishonesty: Please do not cheat or plagiarize. At no time will a student be allowed to use Wikipedia as a source for any project or paper in this class. If it is determined that Wikipedia was used as a source for a project or paper, the student will be given a grade of zero automatically.

# Artificial Intelligence (AI)

Written assignments will be run through a plagiarism and AI checker called Turn It In. If at any

point Turn It In identifies that a student used AI to complete an assignment (such as ChatGPT), an automatic grade of zero will be given to the assignment.

<u>Dropping the course</u>: Please let me know if you plan on dropping the course. Often times, a student will decide to drop a course based upon their own perception of their progress. If I notice a student dropping back, I will do everything possible to bring that student up to speed. Let me help you make the decision to drop. This course is laid out so that a good portion of the grading will be completed prior to the drop date. I will have a section in the "my grades" that will indicate your progress to date to help you in your decision-making process.

Instructor Drop: An instructor may drop a student any time during the semester for excessive absences, for consistently failing to meet class assignments, for an indifferent attitude, or for disruptive conduct. The instructor must give the student a verbal or written warning prior to dropping the student from the class. An instructor's drop of a student takes precedence over the student-initiated course drop of a later date. The instructor will assign a grade of either WF or F through the first 9 weeks of a long semester, the first 6 weeks of a 10 week summer term, or the 12th class day of a 4 or 5 week summer term consisting of 20 days. After these periods the grade will be an F. The date the instructor drop form is received in the Office of the Registrar as the official drop date. A student dropped from a class by a faculty member for disruptive behavior has the right of appeal to the Student Conduct Committee through the Student Conduct office.

I will closely follow this policy in terms of your conduct in class. Anything that is disruptive to the class will result in you being Instructor Dropped from the class with a grade of F. I will enforce this policy in that my obligation is to provide the best and most informative course that I can. I cannot do that when there is behavior that disrupts the class. This also includes attempting to dominate or "teach" the class, interrupting the course frequently with stories that are not facilitative or relevant to the flow of the class, using electronics during class that are not directly related to the class material, and talking frequently to one's peers while course is being held. Any other behaviors that are deemed disruptive will also be enforced as deemed by our Code of Conduct policy. Remember that there are stories and questions that are facilitative to our class discussions, and some that are obstructive.

<u>Informed Consent:</u> This information is to inform the student of the limits of confidentiality while enrolled at MSU Texas or any other state school. Due to federal and state law, faculty and staff working for an university are required to report any information that falls under Title IX. Any student who indicates experiencing sexual abuse/misconduct, physical/emotional abuse, domestic violence, stalking, suicidal/homicidal ideation, or related experiences will have an incident report sent to either the MSU Texas Title IX and/or the Dean of Student's office. # Smoking/Tobacco Policy

#### Alcohol and Drug Policy

To comply with the Drug Free Schools and Communities Act of 1989 and subsequent amendments, students and employees of Midwestern State are informed that strictly enforced policies are in place which prohibits the unlawful possession, use or distribution of any illicit drugs, including alcohol, on university property or as part of any university-sponsored activity. # **Campus Carry**

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes has prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
