Course Description

Interpersonal communication is designed to give students an understanding of communication concepts and practical experience in the communication process. Topics include self-concept, perception, verbal and non-verbal communication, listening, speaking and influencing, conflict management, and mass communication. The impact of gender and culture on communication will be examined. Participation in activities and exercises will provide opportunity to learn how to communicate more effectively in one-on-one, small group, and team situations.

Textbook & Instructional Materials

No textbook is required for this course. Be prepared to take notes each class meeting. If for any reason a student misses a class meeting, it is that student's responsibility to get notes from another student. (Some material covered in class may later be posted in D2L, but again, checking with a classmate can provide context.)

Projects Required

Students will generate an essay outside of class demonstrating ethical reasoning skills. Students will prepare and present a group final presentation. Additionally, students will do daily teamwork, presentation, listening, and analysis exercises in class. (The lowest two grades of daily exercises will not be calculated in determining the student's final grade.)

No extra credit assignments will be given or accepted.

Late Work

Attendance

Change of Schedule

Campus Carry

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes as prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License-to-carry permit, and openly carrying handguns is not allowed on college campuses.

Active Shooter

Each of us has an obligation to be prepared to appropriately respond to threats to our campus, such as an active aggressor.
