Course Description

This course includes a 60 hour field experience in an approved early childhood or early care setting specific to the candidate's career goals. Students will demonstrate developmentally appropriate practices for young children ages birth to age 8 in early childhood and early care settings. This course will be taken in the last long semester before graduation.

### Course Objectives/Learning Outcomes/Course Competencies

The outcomes for graduates of professional programs are based upon knowledge, skills, and dispositions in the following elements:

- Learner Development - understand how learners grow and develop, recognizing that patterns of learning and development vary individually within and across the cognitive, linguistic, social, emotional, and physical areas, and design and implement developmentally appropriate and challenging learning experiences.
- Learning Differences - understand individual differences and communities to ensure learning environments that enable each learner to meet high standards.

- Learning Environment - work with others to create environments that support individual and collaborative learning, and that encourage positive social interaction, active engagement in learning, and self motivation.

Content Knowledge - understand the central concepts, tools of inquiry, and structures of the discipline(s) he or she teaches and creates learning experiences that make the discipline accessible and meaningful for learners to assure mastery of the content.

- Application of Content - understand how to connect concepts and use differing perspectives to engage learners in critical thinking, creativity, and collaborative problem solving related to authentic local and global issues.
- Assessment - understand and use multiple methods of assessment to engage learners in their own growth, to monitor learner progress, and to guide the teacher's and learner's decision making.
- Planning for Instruction - plan instruction that supports every student in meeting rigorous learning goals by drawing upon knowledge of content areas, curriculum, cross-disciplinary skills, and pedagogy, as well as knowledge of learners and the community context.
- Instructional Strategies - understand and use a variety of instructional strategies to encourage learners to develop deep understanding of content areas and their connections, and to build skills to apply knowledge in meaningful ways.
- Professional Learning and Ethical Practice - engage in ongoing professional learning and use evidence to continually evaluate his or her practice, particularly the effects of his or her choices and actions on others (learners, families, other professionals, and the community), and adapt practice to meet the needs of each learner.
- Leadership and Collaboration - seek appropriate leadership roles and opportunities to take responsibility for student learning, to collaborate with learners, families, colleagues, other school professionals, and community members to ensure learner growth, and to advance the profession.

## Objectives

1. Develop relationships with young children including providing a safe and secure environment for young children. (NAEYC 1).
2. Design and implement developmentally appropriate curriculum related to young children's social, emotional, and physical development (NAEYC 1,5).
3. Demonstrate the ability to utilize a variety of modification techniques to allow for individualizing instruction to include all students (NAEYC 1,5)
4. Demonstrate developmentally appropriate approaches to teaching that enhance young children's learning and development (NAEYC 4).
5. Demonstrate use of assessment to make instructional decisions related to a child's social, emotional, and physical development (NAEYC 3).
6. Establish collaborative relationships with children and their families (NAEYC 2).
7. Establish relationships with community partners in early childhood and early care settings (NAEYC 2,6).
8. Design and implement activities in both indoor and outdoor environments with a focus on safety and developmental appropriateness (NAEYC 1,5).

### Submitted Work

Correct spelling and use of appropriate grammatical skills are expected on each written assignment or project. ## Attendance

Students are expected to attend all meetings of the classes in which they are enrolled. Although in general students are graded on intellectual effort and performance rather than attendance, absences may lower the student's grade where class attendance and class participation are deemed essential by the faculty member. In those classes where attendance is considered as part of the grade, the instructor should so inform students of the specifics in writing at the beginning of the semester in a syllabus or separate attendance policy statement. #### Change of Schedule
