**Course Description**

Prerequisite(s): [ART 4143](#) or consent of instructor.

Upper Advanced study in fine art printmaking emphasizing individual development of image and technique stressing production of artworks to be included in the Senior Exhibition. Students will focus on professional development and portfolio preparation. May be repeated for credit.

## **Objectives**

In this course students will: Display a working knowledge of printmaking tools and equipment as it pertains to proper use, maintenance and safety precaution. Acquire a working knowledge and understanding of printmaking media as a learning and creative process. Study the history of printmaking and its connection to contemporary approaches to making art. Demonstrate and master basic techniques, elements and principles of printmaking processes in all areas.

### **Grading Breakdown**

1. Attendance and Studio Etiquette 20%  
Adherence to studio safety and etiquette, willingness to contribute to maintaining the studio, class and critique participation, understanding of cleaning practices specific to printmaking. Mentorship and leadership in the studio.
2. Shop Notebook/Sketchbook and Project Sheets 10%  
Includes documentation of the development of ideas and record of processes for each project/process. Demo Notes. Critique notes and reflections on projects.
3. Artistic Research and Portfolio 70%  
Evidence of independent research relevant to student's artistic practice, including references to contemporary artists for influence. Final portfolio consisting of 5 editions of 5 prints or the equivalent effort. Plans for the semester will be proposed, communicated, and established with the instructor. Plans can be integrated into Senior Exhibition work, but

students must be putting in the unique (not double dipping) 6 studio hours a week allotted to this course.

### **Grading Approach and Evaluation**

Leading up to each project, we will have discussions about my expectations and requirements for each assignment. I will also discuss ideas and sketches with each student individually and monitor your work time as you progress on your editions. All of this will go into consideration with the final result of each assignment. On each project due date, I will take your completed edition along with your sketchbook for grading. I will consider technical skills, exploration, conceptual expression, and improvement/effort.

### **Projects**

All work is expected to be completed and ready for presentation at the assigned date (critique). It is EXTREMELY important to stay up to date with assignments and projects. Late work is unacceptable. Every effort must be made to turn projects in on time.

YOU are responsible for finding out what work was missed during your absence, and turning in work missed due to an absence. I will not remind you that a project was due during your absence.

IF you are absent on a project due date, and IF you are within the three allowable unexcused absences, work is DUE at the beginning of the next class period attended. (See critique section below for absent-during-crit policy).

### **Critiques**

Class critiques are intended to help evaluate the strengths and weaknesses within each project by practicing new vocabulary and design concepts presented in class. They will take place on a regular basis and are designed to encourage the development of your technical and conceptual skills. Your participation and the expression of ideas and opinions in critiques are a major part of this course. All critiques will begin at 9:15 sharp. You are expected to install and uninstall your artwork for critiques (before we start; plan to arrive early on critique days). Prints must be editioned and presentation-ready before critique! Missing critique is equivalent to missing an exam and will be penalized via 5% project grade reduction.

### **Attendance**

Attendance and attitude are influencing factors on your grade. Attendance is always expected, including on "work days". Art requires time—if you miss class excessively, not only will it impact your attendance, but your projects will bear the effect as well (missing out on peer and instructor feedback/interaction). You should come to class prepared to work. Attendance is required for the entire class period. Excused absences are those which involve a documented health problem, family emergency, official university function, or religious holiday. Incompletes for the course will only be considered in extreme cases of personal injury or family emergencies.

**You are allowed only 3 absences!** NOTE THE POLICY FOR CRITIQUE ABSENCES. After 3 absences you run the risk of being penalized via 5% attendance grade reduction. Please email me ahead of time if you will be absent.

### **Studio Access**

The print studio is available for your use whenever scheduled classes are not in session. You must leave the studio better than you find it. The studio, supply cabinet and other materials are accessible via room and lock codes that will be provided. Please keep this information limited to only other students enrolled in the course. Use of equipment, supplies, and presses are for enrolled printmaking students only, and enrolled students can only use what they've been trained in and have instructor permission for.

### **Studio Maintenance**

General studio clean up will be the last 15 minutes of each class session. Students will maintain discipline in studio safety precautions, maintenance and up keep throughout the semester. The instructor will drop those students not willing to take active part in those goals.

### **Conduct Statement**

Classroom behavior that interferes with either the instructor's ability to conduct the class or the ability of other students to benefit from the instruction will result in the instructor's removing the disruptive student(s) from the class, either temporarily or permanently (instructor drop), and receive a final lower grade, up to and including an F. Electronic devices (i.e. cell phones, iPods, iPads, personal computers, etc.) are not allowed to be used in class except with the expressed authorization of the instructor. The use of any recording devices or recording media during the class and lectures is prohibited. Students in violation of these rules will be sanctioned at the discretion of the instructor, and penalties may include lowering of the student's grade, up to and including an F, and to include an instructor drop.

*In this course, the use of generative artificial intelligence is **prohibited**, whether it is for writing or for image generation (even generating sketches/ideas). The use of such tools and programs in this course qualifies as academic misconduct. It conflicts with our course goals of developing personal voice, whether written or visual. We will learn and discuss other strategies of idea development.*

The instructor reserves the right to initiate an instructor drop with a grade of W, WF, or F, as specified in the Student Handbook (see link above) for reasons to include attendance issues, academic performance in the class, indifferent attitude, or disruptive conduct.
