Learning Objectives:

- Increase understanding of self and others
- Improve interpersonal relationships
- Apply psychological theory to interpersonal relationships
- Acquire practical knowledge regarding the development and maintenance interpersonal relationships

Course Requirements:

Examinations:

Students will complete six exams during the course of the semester. Exams will be comprised of multiple-choice and short answer questions.

Material on the exam will include information from the textbook and additional readings for the section, should they be provided.

Each exam will be worth 100 points.

Exams will be taken through D2L. Exams will be timed with a hard cutoff time. There will be insufficient time to look up each answer in the textbook and respond to the written question(s). Therefore, it is important that you have mastered the material thoroughly prior to logging into the exam. Exams will be open book and open note. (Use of Internet resources including AI on the exam will be grounds for dismissal from the course with a failing grade.)

For each exam, students will be provided the option of turning in a copy of the notes that they created for the exam. Those who complete thorough, handwritten notes will be awarded extra credit points towards their final exam score. Only notes that are handwritten in blue ink will be accepted for the assignment. Moreover, your name should be visible in the upper right corner of the first page of notes. You make take these notes using any format that you find to be helpful, however, I would suggest using either the SQ3R method or the Cornell method of note taking.

Assignments:

Students will complete a series of assignments intended to help engage with the course material in a more meaningful way.

- Students will complete a Learning Portfolio Proposal (75 points)
- Students will complete five Learning Portfolio Reports (50 points each)
- Students will complete a Learning Portfolio Review (75 points)

Details regrading these activities will be provided in D2L.

Discussion Posts:

Students will participate in two discussions. For each discussion, students will complete the associated assignment and post the required information to their group discussion board. In addition to posting the requested assignment and associated reflections, students will also respond to the posts of at least two other students. Student grades will be based upon the quality of both the initial post and comments to other students. Each post will be worth 50 points.

(Note: It is important that you follow standards for proper netiquette. Students will be warned the first time that their correspondence violates principles of proper netiquette. A second violation will result in removal from the course with a letter grade of “F.”)

Attendance:
