## Homework

Homework is generally due Wednesday and Saturday every week. You will be expected to: watch lecture videos, write a lecture response, and read and write chapter summaries from your text book. Chapter summaries are due at the end of the semester but I have given you suggested due dates in D2L so you do not fall too far behind.

## Quizzes

At the end of each lesson you will take a self-assessment quiz where you say if you watched the videos in the lesson or not. Each quiz is worth a total of thirty points which is evenly spread out over the number of videos in the lesson. If I discover that you have given yourself credit for a video you did not watch, you will get a zero for the quiz.

## Projects Required

Over the course of this class you will be working on a research project that will have you read a book of your choosing and write a research paper (3-4) pages. The details of this assignment are all available in D2L.

### **Late Work**

I will not accept late lecture responses or the self assessments, but I can give you extensions for your writing projects, if you let me know ahead of time.

### **Desire-to-Learn (D2L)**

### **Change of Schedule**

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

### *Smoking/Tobacco Policy*

### *Alcohol and Drug Policy*

To comply with the Drug-Free Schools and Communities Act of 1989 and subsequent amendments, students and employees of Midwestern State are informed that strictly enforced policies are in place which prohibit the unlawful possession, use, or distribution of any illicit drugs, including alcohol, on university property or as part of any university-sponsored activity. Students and employees are also subject to all applicable legal sanctions under local, state, and federal law for any offenses involving illicit drugs on University property or at University-sponsored activities.

### *Campus Carry*

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes as prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License-to-carry permit, and openly carrying handguns is not allowed on college campuses.
