Course Grade – Your grade will be determined out of a possible 1000 total available points that you can accumulate through the following assignments: ten lecture response, 20 points each for a total of 200 points; ten self assessments worth 30 points each for a total of 300 points; an Unpopular opinion essay, 50 points points, and then your Historic figure assignment which is three writing assignments worth a total of 450 points.

Homework

Homework is generally due Wednesday and Saturday every week. You will be expected to: watch lecture videos, write a lecture response, and read and write chapter summaries from your text book. Chapter summaries are due at the end of the semester but I have given you suggested due dates in D2L so you do not fall too far behind.

Quizzes

At the end of each lesson you will take a self-assessment quiz where you say if you watched the vidoes in the lesson or not. Each quiz is worth a total of thirty points which is evenly spread out over the number of videos in the lesson. If I discover that you have given yourself credit for a video you did not watch, you will get a zero for the quiz.

Projects Required

Over the course of this class you will be working on a research project where you choose a historic figure from the time period of the class and write a Wikipedia style article about the figure. Then you will be randomly assigned either to critique or defend that person. The details of this assignment are all available in D2L.

I will not accept late lecture responses or the self assessments, but I can give you extensions for your writing projects, if you let me know ahead of time.

Change of Schedule

Smoking/Tobacco Policy

Alcohol and Drug Policy

To comply with the Drug-Free Schools and Communities Act of 1989 and subsequent amendments, students and employees of Midwestern State are informed that strictly enforced policies are in place which prohibit the unlawful possession, use, or distribution of any illicit drugs, including alcohol, on university property or as part of any university-sponsored activity. Campus Carry

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes as prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License-to-carry permit, and openly carrying handguns is not allowed on college campuses.
