Personal Application Assignments (90 points): Students will submit 9 personal application assignments (10 points each). Answer 2 or more personal application questions from the textbook at the end of each chapter. Will be submitted in D2L as word documents.

Exams

Exams (200 points): Students will complete **4** exams during the semester. Each exam will be worth 50 points for a total of 200 points. Exams will be multiple choice, but I have the right to include essay questions later if needed.

Research Participation

Research Participation (30 points): It is important that students of psychology experience the scientific nature of the discipline first-hand. All students in PSYC 2203 are required to participate in **ONE** of the following research related activities. ***Only choose one – You cannot receive credit for both!***

- a. **Research study participation:** Participate in approved psychology research projects (**At least 90 minutes**). Research opportunities will be announced throughout the semester and are available at: <https://msutexas.edu/academics/libarts/psychology/undergraduate-research.php>. Completing 90 minutes will be worth **30 points**.

OR

- b. Complete alternative 4-page paper assignment. See me for details.

Our online classes can be accessed from any computer in the world which is connected to the internet. Contact your instructor immediately upon having computer trouble. Recording Classes

Instructor Class Policies

Artificial Intelligence (AI)- Written assignments will be run through a plagiarism and AI checker called Turn It In. If at any point Turn It In identifies

that a student used AI to complete an assignment (such as ChatGPT), an automatic grade of zero will be given to the assignment.

Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester. HOWEVER, if the student received financial aid (federal/state/institutional grants, loans and/or scholarships), all or a portion of the refund may be returned to the financial aid programs. As described below, two formulas (federal and state) exist in determining the amount of the refund. (Examples of each refund calculation will be made available upon request).

Smoking/Tobacco Policy

Alcohol and Drug Policy

Campus Carry

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes has prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
