Tests

Two tests will be given throughout the course. They will account for a total of 20% of your overall course grade.

Final Exam

Projects Required

This course will require three oral presentations, each of which will be assigned at specific times during the semester.

Mid-Term Exam

A timed Mid-Term Exam will be given during Week 8. The exam will be worth 20% of overall course grade.

Extra Credit

I do not typically give or accept extra credit assignments. Students are expected to take advantage of my office hours, utilize handouts, keep abreast with readings and all other course material to earn the best possible grade.

Late Work

Students are expected to turn in all assignments on time, at the beginning of class, on the assigned due date. Late work will not be accepted, unless there are

extenuating circumstances that led to the work being late. I reserve the right to determine whether or not the reason given by the student is legitimate.

Make Up Work/Tests

A student who misses an assignment/test will only be allowed to do a make-up assignment/test if the student missed the original date because of a legitimate reason. Once again, I will determine whether or not the reason is valid.

Desire-to-Learn (D2L)

Attendance

Students are expected to attend all class meetings. Given that this is a communication class, class participation is especially important. If your absence is due to extenuating circumstances, the absence will be excused, at my discretion. However, students with excessive absences will be dropped from the course by the instructor after receiving a warning.

Being more than ten minutes tardy will be counted as late. Three times tardy will count as an absence.

Recording Classes

****Recording classes is generally prohibited without the professor's explicit permission.*** Such recordings, when permitted, are for personal use only and may not be uploaded to the internet or otherwise shared, transmitted, or published without the professor's prior consent. Some faculty may not permit recordings of their classes. When it is feasible and appropriate, students may

record classes to accommodate disabilities under the Americans With Disabilities Act, with prior approval of Disability Support Services. Such recordings may not be uploaded to the internet or otherwise shared, transmitted, or published.

Instructor Class Policies

Students are expected to be respectful of both their peers and the instructor and conduct themselves in a manner that is in accordance with the university's Code of Conduct. Students are expected to bring their writing materials to each class in order to take notes during lectures.

Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester is eligible for a 100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester. HOWEVER, if the student received financial aid (federal/state/institutional grants, loans and/or scholarships), all or a portion of the refund may be returned to the financial aid programs. As described below, two formulas (federal and state) exist in determining the amount of the refund. (Examples of each refund calculation will be made available upon request).

Smoking/Tobacco Policy

Alcohol and Drug Policy

To comply with the Drug Free Schools and Communities Act of 1989 and subsequent amendments, students and employees of Midwestern State are informed that strictly enforced policies are in place which prohibits the unlawful possession, use or distribution of any illicit drugs, including alcohol, on university property or as part of any university-sponsored activity. Campus Carry

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes has prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
