Course Description

Emphasis on the application of demand, supply, & price concepts in the study of natural resource use, policies, & management. Interdependence between environmental quality & economic actions is examined through discussion of property rights, financial incentives, externalities, & economic components of environmental policies.

Course Policies

Attendance Policy:

Students are expected to attend all class meetings for this course, following the university attendance policy. Due to the nature of this course, you are allowed a maximum of four absences in this course, even though there are participation points deducted after you miss your second class. Once you exceed four absences, the instructor has the right to drop you from the course. Each meeting of the class will run as scheduled. So as not to disturb the class, you are not to walk in & out of the classroom during the class time except for an emergency. Cell phone activity (including texting) is prohibited.

Most of the class sessions will be discussion-oriented with ample opportunity for students to provide input to those discussions. Exams will be given in class on paper or at the instructor's discretion the use of online testing through the D2L platform. On-line testing will required to use online proctoring software such as Respondus or a similar software. Students will also be required to have a webcam on the computer where exams are conducted.

There will be one midterm exam and an optional comprehensive final exam that can be used to replace one of the two midterm exams. The exams' structure can include definitions, problems, and multiple-choice questions. Students may use a calculator to solve some problems in the exams, however only non-programmable calculators will be allowed (i.e. TI-30X IIS calculator).

If you miss an exam without prior approval from the instructor, please do not expect a makeup exam. With prior consent, you may take a makeup exam during the week of finals if you wish. If you anticipate a valid reason for missing an exam, please inform the instructor in advance by email. An unexcused absence from an exam will result

in a score of zero on that exam and may be compensated for by counting your final exam in its place with my approval, and a 20% penalty on that exam's score will be assessed.

The exam dates are noted in the Tentative Course Schedule in this syllabus. The instructor can change the exam dates if it is necessary. Any changes in those dates will be announced as soon as possible and posted prominently on D2L.

Quiz Policy:

All quizzes in this course will be of the pop quiz variety and available through the D2L platform <u>OR</u> on paper at the instructor's discretion. Quizzes will be given over the material we are studying and the speakers who visit the class. Please make sure to attend class and pay attention to what is being discussed. Online quizzes will have a fixed time window for students to access and take a quiz. Online quizzes will also have a time limit. No makeup quizzes will be allowed.

Grade Reporting

To help students keep track of their progress toward course objectives, the instructor for this class will provide a Midterm Progress Report through each student's Web World account. Midterm grades will not be reported on the students' transcript, nor will they be calculated in the cumulative GPA. They give students an idea of where they stand at the midpoint of the semester. Students earning below a C at the midway point should schedule a meeting with the instructor.

Final semester grades are reported through normal University channels with no exceptions

Personal Bio:

This assignment requires one page, single-spaced, 12-point font written biography on the student. Students should demonstrate their ability to import a recent photo (approximately 2" x3") into the word document. The document must be uploaded via D2L as directed in the instructions for the assignment

Quizzes:

All the quizzes in this course will be through the D2L platform. Quizzes will be given over the material we are studying and the speakers who visit the class. Online quizzes will have a fixed time window that students will be allowed to access and take a quiz. They may be taken a total of twice before the published deadline. There are no risks associated with retaking the quiz – your highest score is used for the grading. No makeup quizzes will be allowed.

Exams:

During the semester, there will be two midterm exams (100 points each) and a comprehensive final exam (150 points). The three-exam scores will be for 350 points. Every student will be required to take the final exam. The exams' structure can include problems and multiple-choice questions, or they can be take-home exams. You will

need a calculator to solve some of the problems in the exams, so you are required to get a TI-30X IIS calculator. It is the only model accepted to work on the exams.

If you miss an exam without prior approval from the instructor, please do not expect a makeup exam. With prior consent, you may take a makeup exam during the week of finals if you wish. If you anticipate a valid reason for missing an exam, please inform the instructor in advance by email.
