# **Course Description**

The course's primary goal: English 2623 is a literature course that introduces the student to American literary works produced after 1865, encompassing what are generally known as the Realistic, Modern, and Post-Modern periods. The class will emphasize the characteristics of these periods and representational (and occasionally non-representational) traits of the canonical authors.

Secondary objectives: Students will examine ways of knowing in the humanities and ways of approaching literature as a means of understanding life and of interpreting human experience. In particular, this class should also reveal to students the various threads that make up the fabric of our American culture and the impact these texts have on contemporary America and the collective consciousness of our country.

#### **Course Goals**

- Read and analyze a variety of literary texts composed by Americans since 1865.
- Discuss the characteristics of realism, modernism, and post-modernism.
- Evaluate and synthesize credible sources in support of a literary research project.
- Use sources ethically and in contextually appropriate ways and follow a designated style guide (MLA).
- Demonstrate proficient use of Standard Written English.

  - To assess the student's critical thinking skills, the Research Project rubric will be applied to the Literary Research Project.
- Communication Skills

All formal assignments are to be typed, formatted, and outside sources documented according to MLA style. All formal papers will be uploaded into the appropriate D2L Dropbox folder.

# **Change of Schedule**
