Course Description

This class is designed to provide students with a firm foundation in the antebellum South. For generations, the Old South was mythologized, a fact that complicates its history since the region exists largely in the popular imagination. Our aim is to examine the region as it existed. Consequently, some of your readings will be primary documents, written by contemporaries—black and white, northern and southern, men and women, African, American, and European—who moved to, lived in, visited, and otherwise observed the South prior to the Civil War. This class is not designed to offer an encyclopedic history of the antebellum experience. Indeed, the broad geographical and chronological scope of the subject—15 slave states, 11 of which seceded, and two-and-a-half centuries of Anglo-American settlement (to say nothing of French and Spanish influences)—preclude a comprehensive history of the region in a single semester. The class will, however, cover central cultural, social, economic, political, intellectual, and environmental themes that defined antebellum society in the South. It also stresses the critical analysis of historical events and documents to make sense of their (sometimes contested) meanings.

Book Reviews

Students will write a book review on Hyde's *Schooling in the Antebellum South* and Diaz's *A Continuous State of War*. The instructions are as follows: 1) Each book review must be typed in 12-point font, Times New Roman and double-spaced. 2) The margins should be 1 inch on the top and bottom and 1.25 inches on the left and right. 3) To submit each book review, once on our classroom D2L dashboard, click on "Assessments" and then click on "Assignments." You should then see the dropboxes for the Hyde Review and the Diaz Review. The Hyde Review is due by October 9. The Diaz Review is due by December 4.

Movie Assignments

Students are required to write two 5-6-page film critiques. Please select from the list of pre-approved movies posted on D2L under "Movie Assignment Instructions." Each movie assignment needs to be at least 5 pages and no more than 6 pages. Each must be in 12-point font, Times New Roman and be double-spaced. The margins should be 1 inch on the top and bottom and 1.25 inches on the left and right. Movie Assignment #1 is due by September 18. Movie Assignment 2 is due by November 13.

Discussion

Each week, students will post a 2-paragraph response to ONE of the primary documents in that week's assigned chapter of McMillen's *Major Problems in the History of the American South*. "Discussions" can be found on D2L under "Communication." Conversation is strongly encouraged. These discussions are worth 15% of your overall average. Each will be assessed on a 0-100 scale and all will be averaged to deduce your overall discussion grade. You are welcome to start a discussion any Monday, Tuesday, Wednesday, or Thursday. However,

your weekly discussion should be posted by 11:30 P.M. Thursday at the latest. This is to allow your classmates to comment or reply to your post by 11:30 P.M. Friday. When analyzing a primary document, remember the following components: Who is the individual or who are the individuals behind the document? What is the document about? When was the document written? Where was the document written? Why was the document written? What is the document's significance and why does it matter?

Mid-Term Exam

Students are required to take a midterm exam. The instructions are as follows: 1) Once you are on our D2L classroom dashboard, click on "Assessments" near the top of the page. 2) Under the drop-down list, click on "Assignments" and you will see the midterm dropbox. You must upload your midterm into the dropbox by 11:30 P.M. on the due date—October 23.

Final Exam

Students are required to take a final exam. The instructions are as follows: 1) Once you are on our D2L classroom dashboard, click on "Assessments" near the top of the page. 2) Under the drop-down list, click on "Assignments" and you will see the final exam dropbox. You must upload your final exam into the dropbox by 5:00 P.M. on the due date—December 7.

Extra Credit

Extra credit opportunities will be posted under "Content" in our D2L classroom dashboard. Click on "Extra Credit" to see the options. Attending one extra credit will add two point to your lowest book review.

Make Up Work/Tests

Smoking/Tobacco Policy

The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
