Course Description

The main objective of this course is to convey a good understanding of the elementary functions of mathematics (and their related equations and inequalities) in preparation for further study of mathematics such as Trigonometry and Calculus. These functions comprise Linear, Quadratic, Polynomial, Rational, Exponential, and Logarithmic functions. The graphs of these functions shall be extensively studied to underscore their geometric nature. Numerous real world applications of these topics shall be presented.

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester. HOWEVER, if the student received financial aid (federal/state/institutional grants, loans and/or scholarships), all or a portion of the refund may be returned to the financial aid programs. As described below, two formulas (federal and state) exist in determining the amount of the refund. (Examples of each refund calculation will be made available upon request).

Smoking/Tobacco Policy

Alcohol and Drug Policy

The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
