Course Description and Goals

The primary objective of the course is to provide training in rhetoric, including skills involved in the writing process, through composition and reading with the addition of particular skills needed for thoughtful research. By the end of the course, students will be able to:

- > Apply knowledge of rhetoric to make decisions about written communication
- > Engage in a writing process that includes invention, drafting, and revision
- Write thesis-based academic arguments that provide strong support and specific details
- > Find, evaluate, and synthesize credible sources in support of a research paper
- > Use sources ethically, in contextually appropriate ways, following designated style guide
- > Demonstrate proficient use of Standard Written English

Assignments

The major assignments of this course are: a) two in-class, timed essays (TW), b) three formal, revised essays (FE), c) a researched position paper (RPP), d) an annotated bibliography, e) a peer review workshop, and f) a final exam. The course will also include reading materials from the textbook and/or other provided sources, and engagement activities (e.g. quick-writes, labor logs, reading checks, quizzes, activities, etc.).

Grading Policies

This class will not use the plus/minus grading system. In this class, the following numerical equivalents for final grades are used: A = 100-90%; B = 89-80%; C = 79-70%; D = 69-60%; F = 59-0%. Please review the significance of each letter grade (taken from the MSU's Undergraduate Catalogue, p. 73). Essays that meet the basic requirements earn a C, not an A or B. If you wish to earn As and Bs, you will have to work harder to produce better than satisfactory, or average, writing.

Midterm Grades

In order to help students keep track of their progress toward course objectives, I will provide a Midterm Progress Report through each student's WebWorld account. I will submit a grade for all students, not just those in danger of failing the course. Midterm grades will not be reported on the students' transcript; nor will they be calculated in the cumulative GPA. They simply give you an idea of where you stand at the midpoint of the semester. Students earning below a C at the midway point should make an appointment with me and consider taking advantage of the TASP services (see below).

Writing Proficiency Requirement

All students seeking a Bachelor's degree from Midwestern State University must satisfy a writing proficiency requirement once they've 1) passed the 6 hours of Communication Core and 2) earned 60 hours. Students may meet this requirement in one of three ways: by passing the Writing Proficiency Exam, passing two Writing Intensive Courses (only one can be in the core), or passing English 2113. All formal papers will be uploaded to the D2L Assignment folder and/or the Achieve Assignment folder. The "limited right" shall include but shall not be limited to the right to reproduce the student's work product in order to verify originality and authenticity, and for educational purposes.

Note: You may not submit a paper for a grade in this class that already has been (or will be) submitted for a grade in another course, unless you obtain the explicit written permission of me and the other instructor involved in advance.
