Grading

The final grade for the course will be based on the scores earned in the two mandatory exams, the mandatory comprehensive exam, and the average score earned in quizzes and in the homework. The exams each contributes 25%, the comprehensive exam contributes 30%, quizzes average contributes 5%, homework average contributes 10%, and active participation contributes 5%, for a total of 100%.

Homework

All homework assignments will be due at the class period or in dropbox folder provided in D2L on the due date. After the due date, points will be taken off for late homework. Change of Schedule

Smoking/Tobacco Policy

Alcohol and Drug Policy

To comply with the Drug Free Schools and Communities Act of 1989 and subsequent amendments, students and employees of Midwestern State are informed that strictly enforced policies are in place which prohibits the unlawful possession, use or distribution of any illicit drugs, including alcohol, on university property or as part of any university-sponsored activity. Campus Carry

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes as prohibited. The new Constitutional Carry law does not change this process. Concealed carry still
