The primary purpose of providing additional readings and learning exercises is to supplement the accompanying text. They are not intended as a substitute for the text information. They are intended to assist students in assimilating and integrating facts and ideas from the text and to provide additional information and current trends.

Submitting assignments. Attach your assignments as Word documents when you post them in the Dropbox section of Desire2Learn. Please make sure your assignments are in Word 2007 or newer. Always keep a copy of your assignments for your own records. All assignments should be submitted in the format required. APA format should be utilized if a specific format is not disclosed.

Late assignment policy. All assignments are due at 2300 (11:00 PM) on the day due unless otherwise specified. Students are expected to submit assignments by the time they are due. Assignments submitted after the due date and time will receive a deduction of 10% of the total points possible for that assignment for each day the assignment is late. Assignments will be accepted, with penalty as described, up to a maximum of three days late, after which grade of zero will be recorded for the assignment. Students may request an extension by contacting the faculty via email prior to the due date and time. Extensions will not be granted on or after the due date.

Course folders. Course folders have been set up on the Desire2Learn discussion board to facilitate discussion between students and faculty. Course faculty and students can access and post messages related to this course in the folders.

## Syllabus/APA Quiz

- 1. Complete the syllabus/APA quiz located under Tests in D2L.
- 2. Students may use the syllabus and APA Manual to complete the quiz.
- 3. Students will be permitted to take the quiz two (2) times; the grade for the quiz will be the average score of both attempts.

#### **Assignments**

Students will complete three (3) specific assignments for this course. The assignments are designed to encourage the student to reflect on personal values and beliefs about nursing, identify theoretical concepts in evidence-based literature, and discover personal practice concepts. Additional information for each assignment can be found in the Contents Section of D2L. Due dates for each assignment can be found in the Course Calendar.

# Assignment #1

For this assignment, the student will write a short paper (maximum 3 pages) that begins to explore the question: What qualities define a good nurse? The student is expected to ask nursing colleagues, family, and friends to describe a good nurse in

one sentence, summarize the findings, define concepts, and compare with own values and beliefs. APA format (7<sup>th</sup> edition) is required. The completed assignment should be submitted in the designated folder in the Assessment Section of D2L by September 12, 2022.

# Assignment #2

For this assignment, the student will write a short paper (maximum 3 pages) about a memorable patient care experience. The experience could be "memorable" for a variety of reasons, i.e. a good patient outcome, a lesson learned, etc. The student should use the *Nursing Metaparadigm* to frame the experience as follows:

<u>Person:</u> Describe the patient (maintaining confidentiality). Include specific demographic features that would enable to reader to gain an understanding of the patient.

<u>Environment:</u> In what setting did the experience occur? Be specific as to type of facility, unit, etc.

<u>Health:</u> What was the reason for the patient care experience? Include any pertinent diagnoses, procedures, etc.

<u>Caring:</u> Where were you in your nursing career (i.e. years of experience, new to unit, etc.)? What nursing care did you provide or facilitate? What was the outcome of your nursing care?

The completed assignment should be submitted in the designated folder in the Assessment Section of D2L by October 3, 2022.

#### Assignment #3

For this assignment, the student will identify five (5) concepts that define his/her own nursing practice. The student will then depict these concepts, including any relationships they might have with one another, in a concept map. The assignment should include one page of conceptual definitions and one page for the concept map. A title page and reference page are required. Assumptions for this assignment are:

- 1. The goal of all nursing care is to achieve an optimal patient outcome.
- 2. Nursing care can include the patient's family or significant others.

The completed assignment should be submitted in the designated folder in the Assessment Section of D2L by October 24, 2022.

## **Theory Guided Practice, Final Paper**

In this final paper, the student will select a middle range theory from the course text and apply it to a patient care experience. The patient care experience can be the memorable patient care experience from Assignment #2, or a different (past)

patient care experience. The student should use the concepts identified in Assignment #3 to guide the selection of a middle-range theory.

In this paper, the student should include the following:

- Description of the patient care experience using the nursing metaparadigm,
- Rationale for selection of middle-range theory (i.e. similar concepts, setting, etc.),
- Overview of selected middle-range theory, and
- Explanation of how the selected theory will be applied to practice.

The final paper should be in APA format (7<sup>th</sup> edition) and a maximum of 10 pages, excluding title and reference pages. <u>Refer to the grade rubric for this assignment for more details.</u> The completed paper should be submitted to the designated folder in the Assessment Section of D2L by November 14, 2022.

## **Class Participation**

#### **Discussions**

- 1. Students will complete three (3) discussions in which they will synthesize the content of assigned readings and course material into a collegial discussion with peers.
- 2. The discussions are located under Discussions in D2L.
- 3. The grading criteria for discussions can be found in the Discussion Rubric. You should review the grading criteria <u>before</u> making any posts to the discussion board.
- 4. Students are expected to incorporate content from current readings into their initial posts and comments to peers.
- 5. Students will post an initial response to the discussion topic and then provide comments on at least two (2) peers' initial posts.
- 6. Due dates for initial posts and comments to peers are on the Course Calendar and in the Discussion section of D2L.
- 7. You are expected to respond to comments provided by your peers on your initial post as well as on your comments to your peers' initial posts; this will encourage a "back and forth" discussion with your peers.

## Virtual Q & A Sessions

Students are encouraged to participate in the Virtual Question & Answer sessions hosted by your course faculty on Zoom. The sessions are scheduled at points during the semester when students "typically" have questions about upcoming assignments. Students are encouraged to come prepared with questions.
