Course Description: This class gives private one on one instruction in trumpet. It is intended for music majors and minors. The emphasis is on building sound technique, developing strength in the embouchure, learning rudiments, literature, performance skills, and pedagogy.

Objectives:

1. The student will be able to perform scales commiserate with their rate of development.
2. The student will master technical exercises.
3. The student will develop endurance and range.
4. The student will develop their tone.
5. The student will increase the level of sight reading skills.
6. Student will develop performance skills.
7. The student will be exposed to trumpet literature

Evaluation:

1. Every lesson will be graded.
2. Student cannot pass the class without completing two scale projects.
3. Recitals and masterclasses will count as a grade.
4. There will be two masterclasses each term. The student will perform a scale project on each one. They will also perform an etude, solo, or excerpt at each masterclass.
5. Student must play a departmental recital and a jury exam.
6. Final grade based on the average of the above listed.
7. Final grades will be averaged with juries counting as 20% of the final average.

Grading scale for the class will be:

100-90 = A

89-80 = B

79-70 = C

69-60 = D

59 and below = F

COVID-19 Concerns: Because this term takes place in the midst of a global pandemic, all university procedures must be strictly followed.
