Course Description

The primary objective of the course is to develop students' skills in clear and effective composition and standard usage of the English language. In English 2113, students compose, convincingly support, and polish persuasive, thesis-driven essays. The course can be used to satisfy the Writing Proficiency Requirement. By the end of the course, students will be able to:

- Write thesis-based essays that provide strong support and specific details
- Engage in a writing process that includes invention, drafting, and revision
- Demonstrate critical and creative thinking about a timely issue or debatable topic
- Demonstrate proficient use of Standard Written English

Prerequisites

Completion of the Communication Core.

Textbook & Instructional Materials

A textbook is not required for this course, as the material needed will provided by the instructor. However, a style handbook (such as the one listed below) can be helpful.

Required Materials

- A word processor (Google Docs or MSWord) that allows you to save your written assignments as Word Documents.

Desire-to-Learn (D2L)

Use of the MSU D2L program is a part of this course. Each student is expected to be familiar with this program as it provides a primary source of communication regarding assignments, examination materials, and general course information. Assignments

The major assignments of this course are:

- Quizzes. There are ten quizzes. Before taking a quiz, review all the material posted on the quiz topic in the D2L module. Quizzes must be taken during the week they are assigned (i.e., no make-up quizzes). If you take the quiz, you will receive a grade of "1 point," no matter your posted score on the quiz. Your final grammar exam will be based on these quizzes and will count heavily, so don't take the quizzes lightly! Each week's quiz is open from 5 a.m. Monday to 11 p.m. Sunday.
- Writing Assignments. You have five writing assignments: a simple thesis and topic sentence assignment (W1); an assignment in which you submit two body paragraphs (W2); and three complete essays (W3, W4, W5). Assignments will be due on Wednesdays.
- Final Exam. The final exam will consist of two parts: a grammar exam (20%) and a thesis-driven essay (20%). We will use Respondus/ Lockdown browser to monitor the exam.

Grading

Writing Proficiency Requirement
