Dr. John E. Martinez earned his Bachelor of Arts in Economics from the University of Texas, and master's degree and doctorate in economics from the University of Oklahoma. Martinez was hired as an MSU professor of economics in 1997.

In 2006, Martinez was honored by MSU for teaching excellence and service to the university. In 2012, Dr John Martinez was named Hardin Professor, which is the highest honor bestowed upon a faculty member at the university each year. The Hardin Foundation for Wichita County established the annual award in 1962 for a member of the MSU faculty whose teaching and research of the preceding 12 months has brought distinction to the faculty member and the institution. During his tenure at MSU, he has also taught numerous economics courses (11 different preps altogether) from History of Economic Thought to Econometrics.

At MSU, he served many years as the full-time Director of Bureau of Business and Government Research (BBGR). In that capacity he has conducted numerous impact studies that have had important applications for local economic development.

In addition to writing for refereed journals, he has contributed numerous op-ed pieces on various local and national economic issues for the Times Record News (TRN) of Wichita Falls. In the past three years alone, he has written over ten front-page stories for TRN.
