**Course Description.** An instrumental ensemble representing students from all colleges on campus. The band tours each year and performs for local high school assemblies and civic club programs. Membership is by audition (fall and spring semesters).

**Materials.** Each member is issued their own folder and music. Care should be taken to keep the music in good condition. It must be returned free of all rehearsal markings. Lost music is subject to fines up to the total replacement cost of the set.

**Course Goals and Objectives.** Upon successful completion of this course, students will:

1. Be able to distinguish the jazz style from concert stylings
2. Be exposed to a variety of jazz genres
3. Be exposed to basic improvisation
4. Increase their level of sight reading
5. Develop performance skills
6. Be exposed to jazz literature

### **Attendance Policies.**

1. Attendance at every assigned rehearsal is expected
2. Students should arrive early to assemble equipment and be prepared to play at the start of the rehearsal
3. The professor must be notified in advance of any anticipated absence. Official documentation is required for an absence to be classified as excused.
4. Unexcused absences will lower a student's grade and may result in removal from the ensemble
5. Any student who is absent from a performance or dress rehearsal may be immediately removed from the ensemble and receive an "F" for their final grade.

**Classroom Etiquette.** Students are expected to behave in a respectful manner. Disruptions will not be tolerated and are grounds for disciplinary action. Students will refrain from consuming food and beverages (except water) during class. Students may not record, photograph, or video rehearsals without written permission of the instructor. In all cases, posting or publishing of such material is prohibited and is grounds for immediate dismissal from the class. Technical devices such as cell phones, laptop computers, tablets or iPads are not permitted in class, unless being used for a specific, music related purpose. Failure to comply with this may result in a grade reduction or an "F" for the course.

**Concert Attire.** Students are required to dress in "concert black" for all performance. This includes black dress pants/slacks, a black long-sleeve dress shirt/top, black socks, and black dress shoes. No jeans (even if they're black), short skirts/dresses, open-toed shoes, short-sleeve tops, tank-tops, crop tops, low-cut tops, or sneakers. Solid black dresses and skirts are permitted if knee-length or longer. Arms must be covered to the elbows. Look professional. You are representing the university.

**Academic Dishonesty.** The student is responsible for understanding what constitutes academic dishonesty, including but not limited to plagiarism, giving or receiving unauthorized assistance, or submitting for credit work done by another person. The instructor will apply the appropriate disciplinary action at his discretion, which may include receiving a zero on the assignment, being dropped from the course with an F, and/or recommending further sanctions. Familiarize yourself with the Student Honor Creed adopted by the MSU Student Government, which opens with the following statement: "As an MSU student, I pledge not to lie, cheat, steal, or help anyone else to do so."

**Conduct.** The instructor expects students to behave professionally and to devote class time to class work. Instances of disruption and inattention may result in a reduction of the in-class work component of the student's grade or being asked to leave. Removal from the classroom will count as an unexcused absence.

**Students with Disabilities.** The Americans with Disabilities Act (ADA) is a federal anti-discrimination statute that provides comprehensive civil protections for persons with disabilities. Among other things, this legislation requires all students with disabilities be guaranteed a learning environment which provides for reasonable accommodation of their disabilities. Thus, in almost all cases, I will not discuss your academic progress or other matters with your parents. Please do not have them call me. Regardless of these important legal considerations, it is my general policy to communicate with the students, not their parents, even when a student has signed a consent form. College students are adults and are expected to behave accordingly.
