Course Catalogue Description

This course provides a historical and theoretical overview of Western philosophy from classical antiquity through the end of the Middle Ages.

Course Objectives/Learning Outcomes/Course Competencies

This course provides a historical and theoretical introduction to Eastern philosophy and religion. Topics to be discussed will include, but are not limited to, historical origins and development; conceptions of divinity and the sacred; metaphysics, cosmology, and epistemology; sacred texts and religious rituals; theories of human nature and the self; and ethical principles.

The main objectives of the course are as follows:

1. To help students learn and understand the basic issues of Western philosophy from both a historical and theoretical perspective.
2. To help students gain familiarity with various pivotal thinkers, theories, and texts in Western philosophy.
3. To help students develop their skills in interpreting and critically analyzing texts.
4. To help students develop their skills in identifying and evaluating arguments as well as in formulating arguments of their own.
5. To help students improve their ability to read and write clearly and critically. To help students appreciate the relevance of philosophical discourse in public and private life and to gain a greater understanding of their personal philosophical commitments.
6. To inculcate students with a love of wisdom and a desire to live a philosophical life.

Essays

Students in this course will, by the end of the semester, produce on long argumentative (for the 2503 students) or research (for the 4503 students) paper. Writing assignments spread throughout the semester will break down this final paper into various component parts: an abstract/proposal, an annotated bibliography, and drafts of exegetical portions of the essay. This breakdown will allow room for creativity and revision. Students are welcome to propose final essay topics to the professor, but individual essay prompts will also be provided.

Protocols

Students will take turns “kicking off” our discussion sessions. After signing up for which sessions to kick off, each student will be responsible for presenting an overview of the reading, providing the class with 2-3 discussion questions pulled from the “gray area” of the text’s content, as well as (for fun) one “hot take” that the student is willing to defend regarding the reading content. These kick offs are not formal presentations; they are component parts of the course Engagement and are designed to facilitate in-class discussion.

Engagement Reports

Students will write two Engagement assignments throughout the semester. These short writing assignments are not graded individually but their completion will factor into the overall course grade. Individual prompts will be provided at least a week prior to their deadline.

Extra Credit

No extra credit will be accepted in this course. Students are therefore encouraged to keep pace with the syllabus from the start of the semester to avoid a situation in which extra credit would be desired.

Late Work

Assignments submitted late will accrue a late penalty of one-third of a letter grade per day late. Extensions on essays will be granted only in consultation with the instructor in advance and in rare circumstances.

Make Up Work/Tests

Assignments more than a week late cannot be submitted and/or made up. Protocols can only be submitted on the day due and cannot be made up retroactively.

Desire-to-Learn (D2L)

Extensive use of the MSU D2L program is a part of this course. Each student is expected to be familiar with this program as it provides a primary source of communication regarding assignments, examination materials, and general course information. Attendance

Students are expected to attend all meetings of the classes in which they are enrolled. Although in general students are graded on intellectual effort and performance rather than attendance, absences may lower the student's grade where class attendance and class participation are deemed essential by the faculty member. In those classes where attendance is considered as part of the grade, the instructor should so inform students of the specifics in writing at the beginning of the semester in a syllabus or separate attendance policy statement (see next two paragraphs below). An instructor who has an attendance policy must keep records on a daily basis. The instructor must give the student a verbal or written warning prior to being dropped from the class. Instructor's records will stand as evidence of absences. A student with excessive absences may be dropped from a course by the instructor. Any individual faculty member or college has the authority to establish an attendance policy, providing the policy is in accordance with the General University Policies.

Students in this course are graded on "Engagement," which includes but is not limited to attendance. You have to be in attendance to be engaged, but attendance alone does not qualify as engagement. "Engagement" includes attendance, participation in discussion and other course activities, active listening, evidence of preparedness, and the avoidance of distracting/distracted behavior.

There is no distinction in this course between "excused" and "unexcused" absences (with the exception of absences for official university business, like, but not limited to, athletics). Students can miss class for any reason without penalty to their grade, but any student whose cumulative absences amount to three weeks of missed class will be dropped from the course. A student who misses class on the day of his or her Thursday kickoff presentation (without prior arrangement with the professor) will receive a deduction of 10% to their overall Engagement grade.

Online Computer Requirements

Portions of this course make use of online materials. It is your responsibility to have (or have access to) a working computer in this class. ****Assignments and tests are due by the due date, and personal computer technical difficulties will not be considered reason for the instructor to allow students extra time to submit assignments, tests, or discussion postings.*** Computers are available on campus in various areas of the buildings as well as the Academic Success Center. ****Your computer being down is not an excuse for missing a deadline!!*** If you have any computer problems, a student helpdesk available to you. The college cannot work directly on student computers due to both liability and resource limitations however they are able to help you get connected to our online services. Instructor Class Policies

Help — Students should discuss any concerns with the instructor as soon as possible. Many of the readings will be difficult, so *please* ask questions in class for clarification. Office hours are available throughout the week. An appointment is not required for office hours consultation, since they're "drop-in" hours. Appointments can also be made on a case-by-case basis.

Recordings — Lectures, lecture notes, assignments, etc. remain the intellectual property of the instructor. Students are not permitted to disseminate the content of our online class outside D2L.

Conduct — Actions that diminish the quality of other students' learning will not be tolerated. Insults, slurs, or attacks of any kind will be grounds for permanent removal from the course. Every student is expected to engage with the course material in a responsible and respectful manner. This course will include open discussion of a diverse array of philosophical views. Disagreement is normal in classes of this nature; disagreement is conducive to positive learning outcomes, regardless of whether this disagreement pertains between texts themselves, between texts and readers, or between students. Disagreement or debate that turns negative, derogatory, hostile, or otherwise demeaning *in any way* will not be tolerated in class.

Email — Check emails regularly, since that will be the only method by which students are informed about class cancellations or any changes to the course. Your instructor will email you via D2L. Therefore, either make sure you check your D2L email regularly, or change the settings of your D2L inbox to reroute your D2L emails to a preferred email address. When emailing your professors, please ensure that proper etiquette and professionalism is being observed. Always check the syllabus and the course schedule first to ensure that any questions are not already answered there. Your instructor will not respond at length to emails about writing assignments after the assignment has been posted. Please allow 24 hours for an email reply.

Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees. Refund and Repayment Policy
