**Course Description**

A continuation of MATH 3293 with an emphasis on rings, integral domains, fields, ideals, factor rings, and polynomial rings.

Prerequisite: MATH 3293

**Textbook & Instructional Materials**

We will be using the free online textbook Abstract Algebra Theory and Applications by Thomas W. Judson (Stephen F. Austin State University).

You will be graded using the usual 90-80-70-60 grading scale.

### Classwork

Classwork includes attendance, class participation, homework, and completion of other in-class work (such as quizzes or worksheets). Your two lowest quiz/worksheet/homework scores will be dropped at the end of the semester. Makeup quizzes/worksheets will not be given.

Homework will be collected regularly. Any score assigned to homework will be included in the classwork portion of your final grade. Unless told otherwise, you are allowed (and even encouraged) to work with your classmates on homework exercises. However, you must write your own final proofs. Do not

1. write up your final proof with anyone else, or
2. allow another person to read your final proof before it is graded.

Please note that you are not allowed to consult other textbooks or the internet for any of your homework exercises. You may consult other MSU faculty members.

If you turn in a homework problem and do not follow the format required by Dr. Knox (including a failure to give credit to other students/faculty you worked with), you will receive a 0 on the assignment.

If you are caught turning in a homework solution that is not your own work (e.g. a solution taken from the internet or copied from another student), you will receive a 0% for your entire classwork grade for the semester.

If you are caught in an act of academic dishonesty during an exam, you may receive one of the following academic sanctions:

- a 0 on the exam
- an F in the course, and that F may be permanent on your transcript and within your MSU GPA.

### Attendance Policy

Attendance will be taken at the beginning of every class. Any student who is late or who leaves early may be counted as absent. This will result in a zero on any in class work for the day. **Any student who misses six or more classes may be dropped from the course.**

If you miss class, it is your responsibility to

1. get notes from another student for the day(s) you missed (unless you attended virtually), and
2. see Dr. Knox before the next class for any handouts from the day(s) you missed.

You may only attend class virtually if you are in quarantine/isolation. In this case, you must notify Dr. Knox by email no later than 7:40am of the class in which you will attend virtually. Any student attending virtually must complete all of the following in order to be counted present:

1. You must attend the entire class virtually, and late policies still apply. Your camera must be on and you must be visible for the entire class.
2. You must be actively participating, which includes taking notes as if you were in class.
3. You must upload a copy of your completed notes to D2L within three hours of the end of the virtual class.

**If an exam is missed, every effort must be made by the student to notify Dr. Knox in a reasonable amount of time before the exam.** It is best to call Dr. Knox rather than email her when you miss an exam.
